## Sea Cadets See Live Video From Sea Floor; Tour Ocean Exploration Ship

**W**hen plans for NOAA ship *Okeanos Explorer* included a port visit to New York City, the Northern

Virginia Council coordinated with the New York Council to have two Sea Cadet divisions tour the ship between two expeditions to explore deep-sea canyons off the U.S. northeast coast,

In advance of the visit, Sea Cadets were encouraged to check out the seafloor video the exploration team had been sending live to scientists and members of the public ashore as the team explored dynamic but little-known canyons more than 100 miles at sea and thousands of meters deep. Cadets also were encouraged to see live video following the port visit — between Aug. 1 and 16, as scientists returned to explore more of the canyons and a submerged sea mountain.

Video from the ship's exploration team is available at [oceanexplorer.noaa.gov/okeanos](http://oceanexplorer.noaa.gov/okeanos). When undersea robots are operating, video includes seafloor images not seen before, and visitors hear the comments made in real time by scientists on the ship and by greater numbers of scientists ashore as they participate in the mission remotely.

Data collected by the exploration team is made available quickly and openly to the public, and can assist ocean fisheries managers and others

responsible for managing, using and protecting ocean resources.

*Okeanos Explorer* is the only federal ship with a mission to systematically explore the largely unknown ocean for the purposes of discovery and the advancement of knowledge. The ocean is 95 percent unexplored.

Exploration goes far beyond the ship. Through "telepresence," satellite and high-speed Internet pathways connect scientists across the globe with the mission, live. Through standard Internet, anyone with a computer and an internet connection can be a "citizen scientist" and "virtual ocean explorer."

Telepresence-enabled connections stream live video into newsrooms,

classrooms and living rooms, including living rooms of Sea Cadets in New York City.

# Twin Cities Council Helps Fund the USS *Minnesota* Commissioning

The USS *Minnesota*'s commissioning team is run by the Twin Cities Council of the Navy League of the United States.

The Twin Cities Council has raised approximately \$200,000 from private donations to support the commissioning of PCU *Minnesota*, in addition to another \$100,000 of in-kind contributions from two Minnesota companies. There was no legislative match for donations, however one author of the legislation placed a commentary in the *Minneapolis Star Tribune* in July, causing an influx in donations from in from Minnesotans.

At the commissioning in Norfolk on Sept. 7, The Liberty Belles from the USO provided the feature performance at the Chairman's Reception.

In addition to working with the commissioning of the USS *Minnesota*,

the Twin Cities Council also supported the Duluth Tall Ships festival in July (at left), raising more than \$4,400 in donations for the crew.

The council also supports the training of Sea Cadets, with a national training held at Camp Ripley with the Minnesota National Guard.



# Obituaries

## Linda Sloam Mundy (1935-2013)

Linda Sloan Mundy, beloved wife, mother and sister, died at her summer home in North Carolina on June 26. She is survived by her husband of 56 years, Gen. Carl Mundy, 30th Commandant of the Marine Corps, and their three children, Mrs. Elizabeth Gunter, Brig. Gen. Carl Mundy III and Col. Timothy Mundy. Her brother, Dr. Benjamin Sloan Jr., of Plano, Texas, also survives her, together with 11 grandchildren and great grandchildren.

Linda was born Feb. 3, 1935, the daughter of Mr. and Mrs. Benjamin Sloan of Waynesville, N.C. She grew up surrounded by family and friends in the Smoky Mountains, and while in the fourth grade at Waynesville Elementary School, met the boy who would become the love of her life. Linda attended Greensboro College in Greensboro, N.C., graduating in 1957.



After college, she married her fourth grade sweetheart and began her life as the devoted wife of a newly commissioned Marine Corps officer. Over the succeeding years she steadfastly balanced the needs of her family, raised a beloved daughter and two Marine officer sons, and contributed

much to enhance the quality of life for all Marine families. In 1991, she became the First Lady of the Marine Corps, and served Corps and country with grace and humility until her husband retired four years later.

Linda also was a member of the Navy League of the United States' Commodore Club, the precursor to what is now known as the President's Circle.

To those who knew and loved her, Linda was a friend, confidant, ally, counselor, and to her life-long friends, a "sister of the heart." Her warm smile, infectious laugh, wise insights, selfless humility and appreciation for the whimsy in life were but a small part of what made her special. She loved flowers, birds, and animals. She brightened the lives of those around her, lived a good and contented life of her own, and departed it gently. She will be missed.

## Capt. Edgar Prina (1918-2013)

Capt. L. Edgar "Ed" Prina, 94, a prize-winning journalist who was a former Seapower editor and governor of the National Press Club, died May 14 in Washington.

He was born in West New York, N.J., and was a 1938 cum laude graduate of Syracuse University in New York, with a bachelor's degree in journalism and political science. He received a master's degree in political science from Syracuse in 1940.

He began his journalism career in Hornell, N.Y. He served in the Navy during World War II and the Korean War, and served in the Navy Reserve until 1977, retiring as a captain. He published a book, "The Political Virgin," in 1958, and from 1961 to 1968 he was editor of Navy League's

Seapower magazine.

He worked for the Copley News Service, where he covered the Pentagon.

When Prina served as the National Press Club's Speakers Committee chairman in 1989, the club hosted Lech Walesa, Jacques Cousteau and mime Marcel Marceau.

"Ed played a major role, as editor in chief, in reviving the Navy League's monthly magazine and the Navy League itself, both of which had lost membership/readership in the years after World War II," said Jim Hessman, also a former Seapower editor.

"After his own tour of duty at NLUS, Ed gave up his post as editor in chief to become chief of the Washington bureau of the Copley News

Service. But he continued to write a monthly column (several pages devoted to sea-service and national news) for the magazine as well as various feature articles."

Prina also was a charter member of the Navy/Marine Corps Correspondents Circle, Hessman said.

He is survived by Lee Lorick Prina, his wife of 66 years, a daughter, Lee "Lee-Lee" L. Prina, and other friends and relatives.

A Mass of Christian Burial was held on May 21, 11 a.m., at Annunciation Church, 3810 Massachusetts Ave., NW, Washington, DC. The burial at Arlington Cemetery, with full Navy honors, including taps, a horse-drawn casket, Navy drum-and-bugle corps, took place Aug. 26.

Here are some updated and successful “Oldie but Goodie” ideas:

## “Join Up” networking sessions

Thanks to the Mayport and Santa Barbara Councils for sharing this information.

The Mayport Council calls it “Join Up” and the Santa Barbara Council calls it “Topside Tuesdays.” What is it? It is a networking session for members to get together to “meet and greet,” exchange business cards, share interests and still have time to be home for dinner with their families. It is an informal, “come when you can” and “leave when you must” opportunity to meet your fellow Navy League members. Because these sessions are family friendly, attendance by younger members is high. Another benefit is the opportunity to recruit Community Affiliate (CA) members because they compete to host the sessions at their facilities and invite fellow business contacts as potential members. As a bonus, there are no costs to the council when the host serves snacks! The Join Up events are key success factors for the Mayport council to increasing and maintain CA memberships

## Individual Augmentee Recognition

Thanks to Bill Dudley, National Vice President, who originated this program

After Bill Dudley was elected Area President in 2007, he

went to military commands in Northeast Florida to determine if there were additional needs that the Navy League could fulfill. Then-Capt. Jack Scorby, Commanding Officer, Naval Air Station, Jacksonville, Fla. (NAS JAX) (who is now Rear Admiral) requested recognition for Sailors that were detailed for individual augmentation. Individual Augmentees (IAs) are Sailors detailed from their regular command (or Reserve unit) to fill critical vacancies associated with the war. However, because they deploy individually, they return individually and, generally, with little or no “fanfare” (i.e. recognition). So, on April 23, 2008, the inaugural IA Recognition Luncheon was held at NAS JAX for 149 IAs and 56 spouses. Subsequent IA recognition luncheons have been held twice a year with support from the St. Augustine, Daytona Beach, Mayport and Jacksonville Councils.

This Best Practice was publicized in the May 2, 2008, Council Alert and has resulted in other councils — including Honolulu, San Diego, Palm Beach and Tampa — hosting IA recognition events. Today, there are thousands of Sailors who have not received recognition for the sacrifice they and their families have made. As a reminder, the board voted to move to a tiered Life Membership structure and based on this new structure, also cease to offer the Husband/Wife Life category.

We have also introduced a Student Membership category for college students which is an electronic membership that gets their magazine online. So, here are the tiered Life structure and Student Memberships that should appear on your applications:
